The Andhra Pradesh State Biodiversity Board was established under Section 22(1) of the Biological Diversity Act, 2002 vide G.O.Ms.No.68, EFS&T Department dated 11.5.2006 which was notified in the Andhra Pradesh Gazette No.290 dated 20.05. 2006.

In pursuant to the notification of Biological Diversity Act, 2002 the State Government have framed the Andhra Pradesh State Biological Diversity Rules, 2009 vide G.O.Ms.No.70, EFS&T Dept, dated 21-08-2009 for implementing and carrying out the Biological Diversity Act, 2002 in A.P.State with the following objectives

- ❖ Conservation of Biological Diversity
- ❖ Sustainable utilization of the Biological Diversity
- ❖ Fair and equitable sharing of biological resources among all stake holders.

In continuation to the above objectives the A.P. State Biodiversity Board will be **“celebrating International Day of Biological Diversity 2017”** to create awareness among various stakeholders like Members of the Biodiversity Management Committees, Resource user Groups, Bio- resource based traders and industries and other allied Departments Forests, Fisheries, Agriculture etc.,

In this connection, biodiversity conservers who have contributed for conservation of biodiversity/creating awareness on biodiversity conservation. The awardees will be felicitated with an award in International Day of Biological Diversity 2017 to be held on 22<sup>nd</sup> May 2017 at Vijayawada. The A.P. State Biodiversity Board will also provide To and Fro charges (note more than 3<sup>rd</sup> A.C) and accommodation for one day to awardees.

#### Terms and conditions for the nominations:

1. Individuals / Academicians/ Researchers / organizations / firms / CBET/ industries working towards conservation of biodiversity in the State of Andhra Pradesh are eligible.
2. Individuals / Academicians/ Researchers/ organizations / firms / CBET/ industries contributing through their activities / creating awareness towards biodiversity conservation are eligible.
3. The nominations should be recommended by an Government Officer not below the rank of Principal/MPDO/FRO /HOD/ Head of the institute
4. A brief note containing the details of the activities by the nominee should be sent along with declaration.
